

## Positive law codification of certain Public Buildings statutes and Public Contracts statutes – Disposition of Prior Laws

(a) Certain laws relating to Public Buildings and Property and to Public Contracts that had been codified in titles 40 and 41, United States Code, before the enactment of those titles as positive-law titles of the U.S. Code were repealed as part of the codification of existing laws into the new positive-law titles. (1) Public Law 107-217, enacted Aug. 21, 2002, revised, codified, and enacted as title 40, United States Code, **Public Buildings, Property, and Works**, certain general and permanent laws of the United States.

(2) Public Law 111-350, enacted Jan. 4, 2011, revised, codified, and enacted as title 41, United States Code, **Public Contracts**, certain general and permanent laws of the United States.

(b) The following table provides cross references between certain Acts previously codified in titles 40 and 41 and the locations where those Acts were codified as part of the new positive law titles.
